RECEIPT AND ACKNOWLEDGEMENT OF HANDBOOK POLICIES WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

This Parent Policy Handbook has been prepared for your information and understanding of the policies, philosophies, and practices of Laugh-n-Play. Upon completion of your review of this handbook, sign the statement below, and return it to Laugh-n-Play by the due date.

In consideration for my child children _____ attending Laugh-n-Play (hereinafter Laugh-n-Play), I represent, covenant and agree as follows:

1. I acknowledge the risks that may be involved in bringing my child to Laugh-n-Play. I elect to bring my child to Laugh-n-Play and voluntarily accept and assume full responsibility of any risk of loss, personal injury, property damage or harm to my child, which may arise during the activities provided or as a result of having my child at Laugh-n-Play.
2. I waive all claims against Laugh-n-Play, their officers, agents and employees (hereinafter referred to as Releases) for any injuries, damages, losses or claims, whether known or unknown, which arise from my bringing my child to Laugh-n-Play, regardless of whether or not caused in whole or in part by the negligence or other fault of any of the Releases. I release and forever discharge the Releases from all such claims.
3. I understand that Laugh-n-Play does not maintain any insurance policy covering any circumstance arising from having my child at Laugh-n-Play or any activity associated with the care of my child while working at Laugh-n-Play. As such, I am aware that I should review my and my child's personal insurance policy.
4. I agree to indemnify and hold the Releases harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Releases as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Releases.
